

## **RULES AND REGULATIONS, DECLARATION OF ELIGIBILITY, RELEASE OF LIABILITY AND PUBLICITY RELEASE**

**Promotion Name:** Move Over - Snowplow Naming Contest  
**Sponsor:** The California Department of Transportation (Caltrans) and the California Office of Traffic Safety (OTS)

### **How to Enter:**

- Complete the submission form and mark your age group. If a minor, parent must sign submission form.
- Submit a name for the Caltrans snowplow
- Fill out all required contact information
- Agree to the terms and conditions

### **ELIGIBILITY**

This contest will have two different submission categories, one for individuals over the age of 18 years old (Adult) and one for individuals under the age of 18 years old (Minor). Although two submission categories will be offered for this contest, only one snowplow name from districts 1-11 will be selected and entered for a chance to win the grand prize for the contest. ### **STUDENT K-12 SUBMISSION**

This submission option is only open to individuals who (i) are legal U.S. residents of the State of California; (ii) who are under 18 years of age at the time of entry ("Entrant"). Entrant must obtain parental consent to be eligible to enter the Sweepstakes. Parental Consent occurs when the parent or legal guardian of a minor entrant between the ages of 5 and 17 grants permission for the Entrant to participate and agrees on behalf of himself/herself and the minor entrant to these Official Rules. If requested, entrant and/or parent or legal guardian must be able to provide such permissions or proof in a form acceptable to Sponsor. Educators may enter a submission on behalf of a class or student with parental or guardian consent.

### **ADULT SUBMISSION**

This submission option is only open to individuals who (i) are legal U.S. residents of the State of California; (ii) who are 18 years of age or over at the time of entry ("Entrant").

Void outside the state of California and where prohibited by law.

#### **DESCRIPTION OF CONTEST/HOW TO ENTER**

During the Contest Period, visit [www.gosafelyca.org](http://www.gosafelyca.org) or click the available QR code to register for the contest by submitting the entry form with all required information. Entrants must submit a name for the Caltrans snowplow.

No purchase is necessary to enter. All entries submitted become the property of Caltrans and the OTS and will not be returned. By participating, you are granting the Caltrans and OTS perpetual, royalty free license (but without obligation) to use your submission online, on social media and any other media without limitation. Entries must contain all information requested and comply with all content submission requirements set forth herein to be valid.

#### **PRIZES\***

One snowplow name per Caltrans districts 1-11 will be selected. Those 11 selected snowplow names will win a \$50 gift card and be entered for the grand prize.

If the grand prize winner is picked from Student K-12 submission, they will receive:

- (1) Additional \$100 gift card for winning student
- (2) \$100 classroom gift card

If the grand prize winner is picked from the Adult’s 18 and over submission, they will receive:

- (1) Additional \$100 gift card

For the children’s and the adult’s entries, the sponsor and designated panel of judges will determine one prize winner per Caltrans districts 1-11. A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME

OF EXECUTING THE RELEASE, THAT IF KNOWN BY HIM OR HER MUST HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY.

I understand the Released Parties shall not be liable to me or any other person or entity for failure to supply a Prize\* or any part thereof, by reason of any act of God, any action(s), regulation(s) order(s) or request(s) by any governmental or quasi-governmental entity (whether or not the action(s), regulation(s), order(s) or request(s) prove(s) to be invalid), equipment failure, terrorist act, cyber-attack, earthquake, war, fire, flood, explosion, unusually severe weather, hurricane, embargo, talent unavailability, event cancellation, labor dispute or strike (whether legal or illegal), labor or material shortage, transportation stoppage, slow-down or interruption of any kind, work slow-down, civil disturbance, insurrection, riot, or any similar or dissimilar event beyond their reasonable control.

If any provision of this Declaration is unenforceable, it shall either be modified to the extent reasonably necessary to make the provision legal, valid and binding or the provision shall be struck, and in either case the remainder of this Declaration shall remain enforceable to the fullest extent allowed by law. No statements regarding the effect of this Declaration, not contained herein, shall modify the terms of the Declaration. In any proceeding or other attempt to enforce, construe or to determine the validity of this Declaration, the non- prevailing party will pay the reasonable expenses of the prevailing party, including, without limitation, reasonable attorneys' fees and costs. This Declaration shall not be construed for or against either party based on the source of the Declaration. Further, in any such dispute, under no circumstances will I be permitted to obtain awards for and hereby waive all rights to claim punitive, special, incidental, or consequential damages, including reasonable attorneys' fees, other than my actual out-of-pocket expenses (i.e., costs associated with entering this promotion), and I further waive all rights to have damages multiplied or increased.
